MEMORANDUM OF ASSOCIATION

1. Name of the Society :- KERALA YACHTING ASSOCIATION

2. Address & Registered Office:- D 3103, J N I Stadium

3. Area of Operation :- Whole of India, and outside India

4. Aims and Objectives :-

The aims and objectives for which the society is formed are given below :-

- (a) Promote Yachting, Yachting to include all kinds of boating activities with wind powered, manual or mechanized powered vessel.
- (b) Promote sports and organize sporting events.
- (c) Generate harmony in the natural and manmade environment.
- (d) Organize various cultural events for the general awareness.
- (e) Carry out activities deemed fit by the Society Members with social implications.
- (f) To establish, foster and promote the principles of universal justice, love and brotherhood, by Promoting Travel and Tourism.
- (g) To promote among all sections of the people in particular among the youth a deep awareness and respect for the culture and customs of other states and countries.
- (h) To organise programs to increase the inflow of Tourists to Kerala.
- (i) To educate and train young man to become Tourist guides to receive and treat the Tourists in a better way.
- (j) To establish Tourist information centres at various places and publish books and pamphlets regarding places of Tourist importance.
- (k) To co-ordinate the activities of various agencies working in the Tourism field like District Tourism Councils, Tourist Development corporation, Department of Tourism etc.
- (l) To promote and guide other agencies to start necessary infrastructural facilities for Tourists.
- (m) To undertake Socio-Economic Development Programmes, Cultural and Educational Activities etc in the area of the society.
- (n) To extend necessary help financial or otherwise to the poor people, who are in distress, either directly or through other institutions.
- (o) To form district yachting and water sports bodies in kerala for the promotion of sports.
- (p) To conduct district and state level meet, regattas, conduct exhibitions etc.
- (q) To provide and maintain a club house for the use of the members of the club.
- (r) To foster fraternal relations with other yacht Associations or sailing clubs/ Associations in India and/or abroad
- (s) To maintain cordial relations with port authorities, Indian Navy, Coast guard and Kerala State authorities at all times so as to achieve smooth functioning of the first objective.
- (t) To make available and train people in the sport of sailing irrespective of class, creed, religion, sex etc and to broaden base the sport by keeping it inexpensive and making it available to children of all economic strata of society.
- (u) To make suitable representations to central and state Govts including seeking Govt. funds to promote yachting and allied sports activities.
- (v) To raise funds and to receive donations to finance the activities and achieve all aims and objectives of the Association.
- (w) To undertake any other activity as warranted by the circumstances which are helpful to attain any or all the above said objects.

5. Governing Board :-

- (a) The affairs of the Society shall be managed by the Governing Board duly constituted by the General Body, as provided in the rules attached to this.
